# 1 Background:

Sh. Mahendra K. Khattar, the appellant vide DRTI application dated 19.1.2018 has sought information from the Competent Authority notified under the DRTI Act-2001, on total 08 points.

The appellant did not receive any information from the Competent Authority i.e. The Director (Personnel), North DMC. Hence, he filed an appeal before the Appellate Authority, Public Grievances Commission under Section 7 of DRTI Act -2001.

### 2 Proceedings

The appellant is not present. The Officer present on behalf of the respondent viz. The Director (Personnel), North DMC requested for some more time to furnish point-wise reply to the appellant.

#### 1. Decision

A perusal of the record reveals that the application for seeking information was submitted to the Competent Authority on 19.1.2018 and even after lapse of over 04 months, the information sought by the appellant has not been furnished to him.

The Competent Authority i.e. The Director (Personnel), North DMC is hereby directed to furnish the point-wise reply to the queries of the appellant within 10 days from the date

of issue of this order, directly to the appellant, with a copy to the Appellate Authority for information.

The reply should be furnished to the appellant under the signatures of Competent Authority, properly stamped, having the name of Competent Authority (documents, if any, appended with the reply should be certified either by the Competent Authority or an official deputed by the Competent Authority, free of cost.

The Competent Authority shall further submit to the undersigned the reasons for not furnishing the information to the appellant within 30 days of his application, as stipulated under the Delhi Right to Information Act, 2001. The explanation of the Competent Authority must reach the undersigned within 15 days of issue of this order.

With the above directions the present appeal case is ordered to be closed in the Commission.
