1. Brief facts of the complaint

The complainant has filed a complaint regarding inaction and of collusion against the IO of FIR NO. 793/16. He has stated that an FIR was lodged on 17.11.2016 by his wife u/s 376/384/508. He has alleged that from the very next day of lodging the complaint, he has been receiving threats to his life from the accused persons. When he contacted the IO of the case Ms. Mamta Chauhan, she did not listen to him and turned him away saying that he should keep shut otherwise he will be implicated in some false case. He has also exprestsed complete lack of faith in the IO alleging that when the police went to Bihar to arrest the accused he got threatening calls from the accused as they were having all the details regarding the raiding party's programme. He has requested for security of his family and legal action in the matter.

Proceedings in the Public Grievances Commission 2.

The PGC convened its first hearing in the complaint on 12th June, 2017, the second hearing held on 21st August, 2017, the third hearing held on 23rd October, 2017, the fourth hearing held on 8th January, 2018 and the fifth hearing held on 19th February, 2018, when the following were present:-

Relevant facts emerging during the hearing

An ATR has been filed by SI Hema chaudhary, PS K.Khas stating that " the case was registered on the statement of Smt. Shehjadi w/o Mohd. Aarif r/o H.NO. A-451, Gali No. 6, Sri Ram Colony, Rajiv Nagar, Delhi. In her statement she alleged that Mohd. Hussain used to teach her children and she came to know

about him through her step sister Noor Sabha. One day Mohd. Hussain came to her home and told her that Noor Sabha is calling her at her home. There she offered her tea to which she became unconscious and when she gained consciousness she was told by Mohd. Hussain that he had made physical relation with her and threatened her that he had her obscene video and then blackmailed her and on pretext of that had sexual intercourse several times with her. The victim was pregnant. Exhibits of victim and accused were taken and when she delivered the baby, exhilbits of the new born baby was also sent to FSL. The result is being received and is positive and chargesheet against Mohd. Hussain, Supplementary chargesheet against co-accused Noor Sabha had been filed. On 24.1.2017 accused Mohd. Hussain was arrested and sent to JC whereas Noor Sabha surrendered herself. Both the accused are on bail by the Hon'ble court. On the direction of PGC number of accused have been sent for CDR the copy of which is attached to the reply."

4.. Directions of PGC

As per the ATR filed by Delhi Police, the investigation is complete and supplementary chargesheet has been filed in the Court. The Commission has, therefore, decided to close the case in PGC.
