**1. Brief facts of the complaint**

Complaint of inaction against Delhi Police on her complaint of rape and stalking. She has stated that she was repeatedly got raped by her own batch mates and by creating adverse circumstances she has been compelled to leave her job several times at different organizations and places. The complainant has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 05<sup>th</sup> June, 2018 and the second hearing held on 19<sup>th</sup> June, 2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

An ATR has been filed by SI Rajiv, PS Badarpur, stating the following :-

It is submitted that complainant alleged in her complaint that Kiran Bharti, Biswajit, Arnab Banarjee, Gour Pada, Harjender Singh, Sabana and others that they are doing some black magic over her. Due to that she is not feeling well. Kiran Bharti and Baswajit raped her. Now, they are trying to harass her.

In this regard, an enquiry was conducted and on enquiry, it was found that the complainant had already lodged a case at PS Badarpur vide FIR No. 69/2017, u/s 376/506 IPC against Bishwajit and Kiran Bharti. In that case Bishwajit was arrested. As Kiran Bharti committed the rape with the complainant in Noida. Therefore, said information was sent to Noida Police and they have registered FIR NO. 316/17, u/s 376/506 IPC at PS Kotwali, Ghaziabad, UP.

As per the gist of the complainant and telephonically discussion with the complainant, only one incident of rape committed by Bishwajit was occurred in the area of PS Badarpur. FIR NO. 69/17 has already been registered and said case is under scrutiny. No further police action is warranted on behalf of PS

#### **4. Directions of PGC**

The complainant is present and reiterated her allegations as mentioned in her complaint. She further stated that she has been subjected to suffering by her batchmate Shabana and her boyfriends since 2008 by sending guys to rape her and asking her landlord, roommates to torture her (the complainant), as a result she has been compelled to change various jobs to get rid of their tortures but all in vain as everywhere she is being harassed on the instance of the alleged.

SI Rajiv from P.S. Badarpur is present and filed an ATR stating that on her complaint a case had already been lodged at PS Badarpur vide FIR No. 69/2017, u/s 376/506 IPC against Bishwajit and Kiran Bhati. Biswajit has already been arrested. As regards incident of Noida, Kiran Bhati allegedly committed the rape with the complainant in Noida, so the said information was sent to Noida Police and Noida Police has registered case vide FIR No. 316/17, u/s 376/506 IPC, PS Kotwali, Ghaziabad, UP. He further stated that only one incident of rape had occurred in the area of PS Badarpur and the case is under scrutiny by Prosecution Branch.

IO is directed to go through the complaint and co-ordinate for action/present position of the complaints made to various police stations by the complainant so that the distressed woman could be helped and protected from the atrocities.

No further direction needed to police, at this stage.

In view of the above, the proceedings are closed in Commission.
