1. Brief facts of the complaint

The complainant has alleged that he purchased a piece of land measuring 46 ³/₄ sq.yards from Shri Ram Dev in the year 1999. Shri Ram Dev was the owner of total land measuring 140 sq. yards. He further sold land 46 ³/₄ sq. yds. each to Shri Arun and Nagina Yadav. The complainant further purchased 23.33 sq. yards from Shri Arun and thus became the owner of total 70 sq.yards land. Similary, Nagina Yadav also purchased the remaining land from their respective plots. In the year 2004/2005, Shri Arjun (the complainant) rented out the property to Shri Shiv Kumar (alleged person). The complainant further stated that on 30.7.08, accused Shri Shiv Kumar alongwith his son Shri Pawan, wife Smt. Sawitri and Shri Manu, property dealer entered his house forcibly and evicted his tenant Shri Sanjay Prasad and took away his household articles and Rs. 3000/-. Further Shri Shiv Kumar in connivance with accused Shri Mangal Singh, prepared forged documents of property and grabbed the property with the help of other co-accused persons. A case was registered in the year 2011 but the police has not filed chargesheet even after 5 years. The complainant has requested the PGC to direct the local police to file a chargesheet in Court.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 16th March, 2016 and the second hearing on 21st April, 2016, the third hearing on 2nd June, 2016, the fourth hearing on 14th July, 2016, the fifth hearing on 11th August, 2016, the sixth hearing on 1st December, 2016, the seventh hearing on 15th March, 2017, the eights hearing on 31st May, 2017, the ninth hearing held on 2nd August, 2017 the tenth hearing held on 4th October, 2017, the eleventh hearing held on 22.2.2018, the twelth hearing held on 29th March, 2018, the thirteenth hearing held on 17th May, 2018, the fourteenth hearing held on 7th June, 2018 and the fifteenth hearing held on 28th June, 2018, when the following were present:

3. <u>Relevant facts emerging during the hearing</u>

An ATR has been filed by SI Dinesh Kumar, PS Aman Vihar, stating that " the investigation of above noted case has completed. Chargesheet of the case has been signed by concerned ACP. Today, chargesheet of the case to be filed before the Hon'ble Court, but Ld. MM proceeded on TIP and thus chargesheet could not be filed. The same will be filed in the Hon'ble Court tomorrow. Desired action has been taken. The complaint may please be filed/closed."

4. Directions of PGC

SI Dinesh Kumar, P.S. Aman Vihar is present and stated that the chargesheet is ready but could not be filed before the Hon'ble Court as the LD MM Proceeded for TIP and assured the Commission that chargesheet will be filed by tomorrow i.e. on 29.6.2018.

SI Dinesh Kumar sent an ATR on 7.7.2018 and informed the Commission that the chargesheet has been filed in the concened Court on 29.6.2018.

In view of the above, the Commission has decided to close the case in PGC as the case has become sub-judice now.
