1. Brief facts of the complaint

Smt. Sushila filed a complaint in PGC on 10.11.2015 regarding get the water connection unauthorisedly without sanction from Delhi Jal Board. She has requested PGC to do the needful.

The representative of the department DJB informed that they have disconnected the unauthorised water connection at D-43, Laxmi Park, Nangloi, Delhi. They have issued a challan dt. 4.11.2017 and the defaulter Mr. Radhey Shyam had paid the fine on 27.11.2017 to Special Metropolitan Magistrate (Lajpat Nagar).

The complainant has stated that the alleged party is still using DJB water unauthorisedly.

3. Directions of the PGC

Sh. Mathew George, AE-II Project Water-IX, Delhi Jal Board is advised to conduct a joint inspection along with the complainant and inform the Commission about the outcome of the inspection signed by both the parties .

With the above directions, the Commission has decided to close the case.
