1. Brief facts of the complaint

Sh. Madan Lal has registered a complaint in PGC regarding functioning of a polluting unit in shop No. M-146, Shivaji Market, Near Gaon Wala chowk, Raghubir Nagar where painting work is done using chemicals, thinner and paint etc.

2. <u>Proceedings in the Public Grievances Commission</u>

3. <u>Relevant facts emerging during the hearing :</u>

3.1 Sh. Rajkumar, Lic. Inspector, West Zone, is present in the hearing and submitted a report stating that notice was issued to M/s Rajendra Industries, M-146, Shivaji Market, Raghubir Nagar, on 20.10.18 to close down the illegal industrial activity u/s 245-A read with section 491 of DMC Act.

Sh. Rajendra Kr. has closed down the trade of painting of various goods in his premises. He has changed his trade activity to storage/godown in the said premises. He has also obtained online general trade/storage license for the purpose.

3.2 The complainant present in the hearing confirmed the action of the department but at the same time has requested that department be directed to ensure that the industrial activities in the premises under question will not be started again as previously also the activities were closed down with the orders of SDM but had started again after some time.

4. **Directions of the PGC**

Sh. Rajkumar, Lic. Inspector, West Zone, is directed to get the copy of orders issued by SDM in the year 2013, for closure of the factory. He is further directed to ensure that industrial activities (polluting) are not started again on the said premises and direct the owner of the premises to restrain himself from again starting the said activities in the premises under question.

With the above directions in the matter the case stands closed at the level of this Commission.
