1. Brief facts of the case

The complainant has filed a complaint against IO/ASI Surya Kant of PS Mahindra Park for not registering a FIR regarding missing/kidnapping of her husband. She has stated that on 4.12.2016, her husband Pritam Singh, aged 53 years had gone to attend the marriage of his relative in Village Bhadola, near Azadpur Subzi Mandi alongwith his friend Ramashankar. She alleged that her husband was made to drink by Ramashankar and after the marriage, her husband got disappeared suddenly. She lodged a complaint of Missing on 7.12.2016 with Police Chowki Azadpur Mandi vide DD NO. 29 PP. The complainant has also stated that she came to know that her husband Pritam Singh had illegal relations with Kailashi, and Ramashankar also knows that illegal relations. She also stated that before missing of her husband, her husband made a transaction of selling of ancerstral property with the builder (Ballue) of Nirankari Colony, and her husband got Rs. 1 lakh as token money (Bayana). The market value of her husband's ancestral property is Rs. 10 crore. She also stated these facts to IO/ASI Suryakant but he has not taken action action regarding registration of FIR in the matter. She has apprehension that Ramashankar, Kailashi and his son Jitender either had kidnapped her husband or got him murdered to grab his property. The complainant has requested for legal action in the matter.

2. Facts emerged during the hearing

2.1 ASI Jagat Singh from PS Mahindra Park is present and filed an action taken report which has been taken on record.

2.2 ASI further stated that plot bearing property No. 1564, gram Loni Gaziabaad, UP in the name of Kailashi Devi has been verified and during enquiry Kailashi devi stated that her son Jitender got married and his father in law gifted Rs. 4 lakhs to his daughter besides some contribution from family savings, the said plot was purchased. The plot was purchased for Rs. 5,80,000/- on 9.3.2015 from Suresh Chand. He further stated that the witnesses of the said plot Jitender Kumar and Chhote Lal were also examined. Both of them stated that the whole payment of Rs. 5,80,000/- was handed over to Suresh Chand in front of them. The property document was showed to the complainant Chander Kala as well as her son Gajender for their satisfaction. The progress of the case was also shared with them on day to day basis. Efforts are underway to trace him.

3. Directions of PGC

3.1 Police should make sincere efforts to trace the missing husband of the complainant and update the complainant about the progress of the case once in every fortnight.

3.2 Complainant is advised to share any input /clue regarding her missing husband to enable police to conclude the investigation.

3.3 With the above advice, the Commission has decided to close the case in PGC.
