1. Brief Facts of the Case

The complainant has filed a complaint stating that he was returning to his home on 9.11.2018 after duty, one PCR NO. DL-1-CP-7539 stopped him and asked him to give them some money on account of "Diwali". They forcefully took out Rs. 500 from his pocket. He lodged a complaint in this regard. He alleged that IO is threatening him to implicate him in a false case. He further alleged that his friend Ashok Kumar, who is witness to the incident, is also getting threats from the IO. The complainant has requested for action in the matter.

2. Facts emerged during the hearing

ASI Ram Pal from PS Vikas Puri is present and filed action taken report, which has been taken on record. He further stated that on receipt of PCR call, he alongwith HC Lalaram reached the spot but the complainant was not found at the spot. He contacted the complainant on his mobile number 7982535415 and he stated that he is residing at House NO. 10, Jal Board Staff Quarter, Vikas Puri, New Delhi, but no one was found at the said address. Local enquiry from the neighbours revealed that the complainant had left the said address one year back and shifted to Chander Vihar. He (E.O.) called him several times on his mobile phone but he refused to meet and subsequently switched off his mobile phone. He also enquired the staff deployed in PCR Van NO. DL1CP 7539 and recorded their statement in which they stated that

they received a QST from Power-1 at 12.45 a.m. that cattle's are being transported by a TATA-407 vehicle towards Peeragarhi. They are directed to take position at DJB, Outer Ring Road towards Peeragarhi and when they reached there, they found one Wagnor Car NO. DL 1R-TB-2750 and one motor cycle No. DL 4SDH 0126 parked abandoned at service road and two persons were found drinking alcohol inside the Wagnor Car. When they told them to leave the place, one person inside the car Virender and the other person who is a taxi driver, namely, Ashok left the place. After some time the complainant Virender who was drunk turned back and began to behave aggressively and threatened them to spoil their career. He made a fake call about taking of DL,RC and Rs. 500/-. He (ASI Rampal) called the friend of Ashok to the police station and conducted enquiry. He stated that he went away from the spot after the PCR vehicle came and Virender (the complainant) made a fake call regarding taking of DL, RC and Rs. 500/-. Ashok was also got medically examined and doctor. opined his BAC reading as 164.9 mg. Also, Virender in his written statement has admitted that he has made a false call to PCR even though no money was taken from him by the police personnel.

3. Directions of PGC

- 3.1 The case was heard in the Commission on 12.12.2018 and from the report submitted by the SHO/Vikas Puri, it is clear that prima-facie the call to PCR was made under the influence of alcohol. His associate Ashok Kumar, who runs a private taxi and with whom the complainant was drinking alcohol that evening, was got medically examined from DDU Hospital and the doctor has opined that his BAC reading is 164.9 mg, which is much higher than the permissible alcohol content in the blood. Considering the fact of the matter and also the fact that the complainant has leveled false allegations against the police personnels, the continuance of such a person in Civil Defence is not desirable. Action as deem fit including the dismissal or striking out his name from the Civil Defence is recommended.
- 3.2 A copy of this hearing Order is also being sent to Director General of Delhi Home Guard/Civil Defence, Raja Garden, New Delhi and DM (West), Govt. of NCT of Delhi for necessary action in the matter.
- 3.3 With the above advice, the Commission has decided to close the case in PGC
