ORDER

This order shall dispose off the appeal filed by Sh Tarsem Chaudhary, Appellant in respect of RTI Appeal in RTI ID No. 939 u/s 19 of RTI Act, 2005. Notices were issued to both parties for appearing on 19.12.2017. Appellant and Sh Tanuj Bhanot, AR/PIO (Policy) were present. Assistant Programmer/PIO (Computer Cell) not present.

The appellant who appeared submitted that he is not satisfied with the reply given by the Assistant Programmer/PIO (Computer Cell) at point no. 3, 5 to 11. The PIO (Policy) who appeared submitted that the information asked in point no. 3 of RTI ID No. 939, the land owning agency is DDA. As regard, registration policy, the appellant is advised to see DCS Act and Rules which is available in the website i.e, http://www.delhi.gov.in/wps/wcm/connect/DOIT_RCS/rcs/home/.

The information asked in point numbers 5 to 9 pertains to DDA. Therefore, PIO (Policy) is directed to transfer the RTI to DDA within a week.

As regard, information asked in point number 10 of RTI ID the PIO (Policy) submitted that it relates to DCS Act and Rules which is available in the website i.e, http://www.delhi.gov.in/wps/wcm/connect/DOIT_RCS/rcs/home/.

As regard, information asked in point number 11 of RTI ID the PIO (Policy) submitted that it relates to cooperative society and cooperative society is not a public authority. Therefore, the appellant is advised to file RTI under section 139 of DCS Act, 2003 before the cooperative society.

The appeal is disposed off accordingly.

If the appellant is not satisfied with the order of First Appellate Authority then he may file second appeal before Second Appellate Authority i.e, Central Information Commissioner, CIC Bhawan, Baba Gangnath Marg Munirka, New Delhi - 110067.
