ORDER

Whereas, SBI Sub-Staff Co-operative Group Housing Society Ltd., State Bank Colony, Near Sant Nagar, Pitampura, Delhi-110034 is registered with this Department vide Regn. No.73/GH.

The other terms and condition will remain same, as conveyed vide earlier order dated 07.02.2017.
