Whereas Sh. Ajay Kaushal, earlier appointed by this department as Administrator U/s 35(5) of DCS Act, 2003 in Philips Co-operative Group Housing Society Ltd. to conduct the election in the society but the election could not be conducted due to non finalizing the list of eligible and defaulters members and audit upto 2011-12 to till date is also pending.

Whereas in exercise of power vested U/s 37(1) of DCS Act, 2003 the Competent Authority (Registrar Cooperative Societies New Delhi) is pleased to appoint Sh B.S. Rana (Retd. Supdt. Education Department) as Administrator in place of Sh. Ajay Kaushal to manage the affairs of the society for a period of 180 days and get the audit conducted for the period 2011-12 to 2016-17 after taking charge of the society from Previous Administrator/Managing Committee/Custodian of the society.

Sh B.S. Rana, will also submit monthly progress report about the status of affairs of the society by 10th of every month. Further, Sh B.S. Rana will be paid honorarium of Rs. 10,000/- per month from the society's fund.
