And whereas, no confirmation of calling of SGBM U/s 33 (1) of DCS Act has been received in this office.

And whereas, the MC of the society has failed to call the SGBM and meanwhile, a letter dated 16-01-2018 signed by Sh. Dinesh Widge & Suman Dev has been received in this office wherein, the signatories have informed that due to non co-operation from the defaulter members and no response from this office "the present management has decided to relinquish their job hence forth the resign from their post, duties and responsibilities with immediate effect with a request to initiate necessary further action as required."

In view of above, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested with him under DCS Act & Rule, is pleased to appoint Sh. Jitendra Kumar Singh, Assistant Registrar to call the SGBM on the agenda of '**No Confidence Motion**' U/s 33(2) of DCS Act 2003. An honorarium of Rs. 6,000/- (Rupees Six Thousand Only) besides other expenses incurred towards conduct of SGBM will be given to him out of the society funds.
