**ORDER**

Whereas, Navyug Adarsh CGHS Ltd, F-Block, Vikas Puri, New Delhi-110018 is registered with this department vide Regn. No. 352/GH under the provisions of DCS Act and Rules.

And whereas, 08 members out of 15 members of M.C. resigned from their posts and whereas, 88 members out of 260 (freeze strength) of the society moved '**No Confidence Motion**' under section 36 of DCS Act against the M.C. of the society.

And whereas, the President of the society failed to call the SGBM despite opportunity being given vide this office letter dated 20.06.2017 to call SGBM at their own, but in-spice of this, the President vide letter dated 07.07.2017 informed that he has dissolved the M.C. of the society, which was not as per DCS Act & Rules.

And whereas, vide this office order dated 12.10.2017 Sh. Tanuj Bhanot, Asstt. Registrar was appointed to call the SGBM U/s 33(2) of DCS Act 2003 in Navyug Adarsh CGHS Ltd. Accordingly, as per report submitted by Sh. Tanuj Bhanot he had convened the SGB meeting on 29.10.2017 and appointed ad-hoc committee to take care of the day-to-day work of the society.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoints Sh Kulgeet Singh (Retd. Cont. of Account), as Administrator-cum-Returning Officer in the Navyug Adarsh CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the affairs of the Society and hold the election of the Managing Committee of society within Ninety (90) days from the date of appointment. An honorarium of Rs.10,000/-(Rs.Ten Thousand only) per Month will be paid to him from the society funds. The Administrator-cum-Returning Officer, on expiry of the period of 90 days shall not exercise any financial powers till the term is further extended by the competent authority.

This issues with the prior approval of the Competent Authority.
