**ORDER U/S 35(5) OF DCS ACT, 2003**

Whereas, the Delhi Co-operative Group Housing Society Ltd. is registered vide registration No.504-GH with this department under the provisions of DCS Act & Rules and bye-laws of the society;

Whereas, it is submitted that a letter has been received in this office vide dairy No.2020/(ARH-II) dated 28.09.2017 from members of the Delhi Co-operative Group Housing Society Ltd. alongwith the photocopy of notice board wherein 07 members of Managing of the society has resigned on 24.09.2017 and it is also submitted that resignation of 07 individual members of managing committee vide letters dated 24.09.2017 were also received in this office on 25.09.2017 due to misbehavior with Secretary of Managing Committee in the Annual General Body Meeting held on 24.09.2017.

Whereas, in this connection, it is submitted that the last audit of the society was conducted for the financial year 2014-15 and 2016-2017 is under process with Audit branch of this office and last election of the society was held on 26.07.2015.

Now, I Kulvendra Yadav, Assistant Registrar (GH-II) hereby convey the approval of the Competent Authority to appoint Mr. Rajnish Singh (ADM, Shahdara) as Administrator-Cum-Returning Officer in Delhi Co-operative Group Housing Society Ltd. under Section 35 (5) of DCS Act, 2003 in place of Mr. Chandan Sengupta, Deputy Secretary (Power) with immediate effect at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society for processing the case of election of the Managing Committee of the society within stipulated period 90 days from assuming the charge as Administrator-Cum-Returning Officer.

Mr. Chandan Sengupta, Deputy Secretary (Power) is hereby directed to handover the charge and also the record/ relevant documents of the society to Mr. Rajnish Singh (ADM, Shahdara) Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
