ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, the ESIC Friends Co-operative Group Housing Society Ltd. is registered vide registration No.576-GH with this department under the provisions of DCS Act & Rules and bye-laws of the society;

Whereas, Dr. S.K. Tripathi President of the society has informed this office vide letter dated 14.09.2017 (copy enclosed) that the all office bearers of Management Committee of the society has tendered their resignation with immediate effect and requested to accept the resignation and initiate the process of fresh election of Management Committee of ESIC Friends Co-operative Group Housing Society Ltd. due to unavoidable circumstances.

Whereas, in this connection, it is submitted that the last audit of the society was conducted for the financial year 2015-2016 and last election of the society was held on 29.05.2016.

Now, I Kulvendra Yadav, Assistant Registrar (Sec-II/GH) hereby convey the approval of the Competent Authority to appoint Mr. Tapan Jha, Deputy Secretary (Land & Building Department) as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 with immediate effect at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society for processing the case of election of the Managing Committee of the society within stipulated period 90 days from assuming the charge as Administrator-Cum-Returning Officer.

President/Secretary of the society is hereby directed to handover the charge and also the record/ relevant documents of the society to Mr. Tapan Jha, Deputy Secretary (Land & Building Department) Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
