ORDER

Whereas, New Avantika CGHS Ltd., Flat No 3, C-27, S.F., Near Sai Baba Chowk, Madhu Vihar, I.P. Extn, Delhi is registered with this Department vide Regn. No.657/GH.

Whereas, the term of the present Management Committee of the New Avantika CGHS Ltd. has already expired in Oct 2015.

Whereas, vide order dated 18-12-2017 Sh. Manoj Kaushik, Section Officer, Urban Development Deptt. Delhi, was appointed as Administrator in the New Avantika CGHS Ltd. under section 35(5) of DCS Act, 2003 for 90 days.

Whereas, vide letter dated 12-03-2018 the Administrator has informed that list of members and list of defaulter members have been prepared and displayed on the notice board of the society office on 05-03-2018 and also requested to appoint Returning Officer to conduct the election in the society.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, extend the tenure of Sh. Manoj Kaushik, Section Officer, Urban Development Deptt. Delhi, as Administrator in the New Avantika CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the affairs till the election of the society may conduct in the New Avantika CGHS Ltd. or for ninety days from the date of his appointment, whichever is earlier. The Administrator, on expiry of the period of 90 days shall not exercise any financial powers till the term is further extended by the competent authority. An honorarium of Rs.10,000/- (Rs.Ten Thousand Only) per month will be paid to him from the society funds.
