Director, Dte. of Education, Distt West-A, Karampura, Delhi was appointed as Administrator-cum-Returning Officer u/s 35(5) of DCS Act, 2003 vide this order of even number dated 06.02.2018 to manage the affairs of the society and to conduct elections to the Managing Committee of Vasant CGHS Ltd.
