ORDER

This order shall dispose of the appeal filed u/s 19 of the Right to Information Act, 2005 by Sh. Rejimon C.K. dated 2.4.2018.

The appellant Sh. Rejimon C.K. had filed an online RTI vide ID No. RCOSO/R/2018/60022 on 19.02.2018 seeking information on 17 points. A reply/information was provided by PIO (Sec-6) vide letter dated 14.3.2018 but the appellant is not satisfied with the reply of the PIO (Sec-6). Notice was issued. None present for the Appellant. PIO (Sec-6) was represented by Sh. Satish Kumar, Gr. II. The representative of PIO has submitted the information/reply of RTI sent to the appellant.

On perusal of the information sought by the appellant it is observed that on many item nos why, reason etc. has been mentioned for seeking the information. In addition to this the reply has been given that the desired information has not been given in the compiled form. In many cases the information is already available on the website of the Department. In item no. 12 to 17 the PIO has replied no such information is available in Housing Section -6. The information provided is not satisfactory. The PIO should have sent the RTI application to the concerned sections. Accordingly the Item No. 12, 13 & 14 is to be provided by the Policy Branch and Item No. 15, 16 & 17 is to be provided by the Computer Branch. The PIO (Policy Branch) and PIO (Computer Branch) are hereby directed to provide the required information to the appellant within three weeks of the issue of this order.

The appeal is disposed of accordingly.

As per Section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, Club Buildings, Opposite Ber Sarai Market, Old JNU Campus, New Delhi-110067.
