Whereas, **Jan Hit CGHS Ltd.**, Plot No. 25/2, Sec-9, Rohini, Delhi-110085 is registered with the Department vide Regn. No. 320 under the provisions of DCS Act and DCS Rules enforce in NCT of Delhi time to time.

Whereas the election of the society is not being held since April, 2010 and the last Audit of society funds were conducted for 2014-15 and the society has failed to conduct the election as per DCS Act 2003 and DCS Rule 2007.

Now, therefore, keeping in view of the above circumstances, the Competent Authority i.e. Registrar Cooperative Societies is pleased to appoint Sh. V.K. Bansal, (Retd. ARCS) as Administrator-cum-R.O of the said society under Section 35(5) of DCS Act, 2003, in place of Sh. Vivek Kumar, SDM due to his resignation, for managing day to day affairs of the said society and also to hold elections of the Managing Committee within 90 days from the date of his appointment. For the purpose a remuneration of Rs. 10,000/- (Rupees ten thousand only) per month will be paid to the Administrator-cum-R.O. from the society's fund.

Further, the matter of appointment of Administrator in the society is pending before the Hon'ble Finance Commissioner vide appeal No. 97/2018, titled as Sh. K.L. Malhotra V/s. Asstt. Registrar which is due for next hearing on 17.07.2018 only substitutes the name of the Administrator and his appointment will be subject to the final outcome of the case which is pending before the Finance Commissioner.
