ORDER

Whereas, the Dakshini Delhi Co-operative Group Housing Society Ltd. is registered vide registration No. 122-GH with this department under the provisions of DCS Act & Rules and bye-laws of the society;

And whereas the Registrar Cooperative Societies has now granted approval of the appointment of Sh. Ravinder Kumar Sadda, Deputy Secretary (Finance) as Administrator cum Returning Officer under Section 35(5) of DCS Act, 2003.

And whereas member of the society has filed petition before the Hon'ble High Court of Delhi for non conduct of election in the society vide WP (C) No.7617/2018 matter titled as "*Ms. Sarita Vs. Registrar Coop. Societies & Anr.*" (Copy enclosed) and the next date of hearing in the matter is 26.11.2018;

Now, therefore, I, Gulshan Ahuja, Assistant Registrar/ Link Officer (GII-II) hereby conveys the approval of the Competent Authority to appoint Sh. Ravinder Kumar Saddoo, Deputy Secretary (Finance) as Administrator under Section 35 (5) of DCS Act, 2003, in place of Mr. Suraj Bhan (Retd. DANICS) with immediate effect at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society who shall conduct election of the Managing Committee of the society within stipulated period 90 days from the date he assumes the charge as Administrator.

Mr. Suraj Bhan, (Retd. DANICS) is hereby informed to handover the charge and also the record/ relevant documents of the society to Sh. Ravinder Kumar Saddoo, Deputy Secretary (Finance) Administrator immediately under intimation to this office within 07 days from the issue of this order. He is also requested to submit the copy of enquiry report alongwith record submitted to the committee of Judges who were appointed by the Hon'ble High Court of Delhi in WP (C) No.9880/2004 matter title as "*Shashi Dna Vs. Registrar Co-operative Societies*" vide order dated 02.03.2017 for conduct of enquiry.
