**ORDER**

Whereas, the Ministry of Home Affairs Govt. Employees Hire Purchase Co-operative Society Ltd. is registered vide registration No. 307(S) with this department under the provisions of DCS Act & Rules and bye-laws of the society;

And whereas the Registrar Cooperative Societies has now granted approval of the appointment of Sh. Chandan Sengupta Adoc. DANIC, Deputy Secretary, C. M. Office as Administrator-cum-Returning Officer under Section 35(5) of DCS Act, 2003.

And whereas the members of the society have filed complaints wherein it has been informed that:-

*"They are members of the Ministry of Home Affairs Govt. Employees Cooperative Society Ltd want to inform that the above mentioned existing Managing Committee has declared the election of the Managing Committee on 12<sup>th</sup> January 2019 after a period of 8 years a per advertisement published in Hindustan Times (English and Hindi) Which is clear violation of the Rules and Regulations on the subject matter. As per bye-laws, the election should be held within a period of three years. He therefore request that these elections should be conducted under the supervision of Administrator as per section (4&5) of DCS Act, 2003."*

Now, therefore, I, Kulvendra Yadav, Assistant Registrar (T&C) hereby convey the approval of the Competent Authority to appoint Sh. Chandan Sengupta Adoc. DANICS, Deputy Secretary C. M. Office as Administrator under Section 35 (5) of DCS Act, 2003 at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society who shall conduct election of the Managing Committee of the society within stipulated period 90 days from the date he assumes the charge as Administrator.
