ORDER UNDER SECTION 35 (5) OF DCS ACT, 2003

Whereas, the Delhi Co-operative Group Housing Society Ltd. is registered vide registration No.504-GH with this department under the provisions of DCS Act & Rules and bye-laws of the society framed there under;

And whereas, it is submitted that a letter has been received in this office vide dairy No.2020/(ARH-II) dated 28.09.2017 from members of the Delhi Co-operative Group Housing Society Ltd. alongwith the photocopy of notice board wherein 07 members of Managing of the society has resigned on 24.09.2017 and it is also submitted that resignation of 07 individual members of managing committee vide letters dated 24.09.2017 were also received in this office on 25.09.2017 due to misbehavior with Secretary of Managing Committee in the Annual General Body Meeting held on 24.09.2017.

And whereas, Mr. Rajnish Singh (ADM, Shahdara)/Administrator-Cum-Returning Officer has resigned vide letter dated 07.06.2018 due to transfer from the post of ADM (Shahdara) to Joint Secretary (Vigilance). Further Mr. Vivek Aggarwal, ADM (North-West) was appointed vide order dated 12.09.2018 and he has also resigned vide letter dated 05.12.2018 due to great distance from his office to society and has expressive work too.

Now, I Kulvendra Yadav, Assistant Registrar (GH-II) hereby convey the approval of the Competent Authority to appoint **Mr. Ashish Kumar Deputy Secretary (AR/PGMS)** as Administrator-Cum-Returning Officer in Delhi Co-operative Group Housing Society Ltd. under Section 35 (5) of DCS Act, 2003 in place of Mr. Vivek Aggarwal, ADM (North-West) with immediate effect for conducting of election of the Managing Committee of the society within stipulated period of 90 days from the date of appointment as Administrator-Cum-Returning Officer. The society will pay **₹.10,000/-** (Rupees Ten Thousand Only) per month to the Administrator-Cum-Returning Officer.
