SANCTION ORDER

Subsequent to convey of the approval of the Competent Authority i.e. Hon'ble LG, Delhi regarding grant of study leave to Sh. Jorawar Singh, Supdt.(ex-cadre) for doing M.Phil from GGSIP University, Delhi in the field of Psychiatric Social Work w.e.f. 01/09/2018 to 31/08/2020.

The Study Leave is being granted subject to the following terms and conditions:-

1. The officer will have to execute Indemnity Bond in Form-7 as per Rule 53(4) of the CCS (Leave Rules), 1972 for the period of his study leave before proceeding on leave.
2. The leave salary during the period of study leave shall be borne by the Govt. of NCT of Delhi.
3. He shall draw Leave Salary equal to the pay that the Government servant drew while on duty with Government immediately before proceeding on such leave and in addition the Dearness Allowance and House Rent Allowance as admissible in accordance with the provisions of Rule 60.
4. Payment of leave salary at full rate under Clause (a) shall be subject to furnishing of a certificate by the Government servant to the effect that he is not in receipt of any scholarship, stipend or remuneration in respect of any part-time employment. The amount, if any, received by a Government servant during the period of Study leave as scholarship or stipend or remuneration in respect any part-time employment as envisaged in sub-rule (2) of Rule 57, shall be adjusted against the Leave Salary payable under this sub-rule subject to the condition that the Leave Salary shall not be reduced to an amount less than that payable as Leave Salary during half-pay leave.
5. The officer shall not be allowed to take up any assignment/consultancy or any assignment with any non-government organization during the bond period.
6. No study allowance shall be paid during Study Leave for courses of study in India.
7. **The member of Service** shall provide e-mail address for communication to State Govt. and shall intimate, change if any, in his mailing address from time to time.
8. The officer shall submit full report on the work done after the completion of study.
9. **If the member of the Service** fails to return to duty at the end of the period of leave or any extension authorized thereto he may be deemed to have resigned and that he foregoes his right to any prior notice or any show cause notice before the State Govt takes action in this regard on the basis of continued absence from his duties.
10. **Permission/NOC can be withdrawn in office/public interest at any time.**
11. The study leave shall be subject to other conditions as indicated in the CCS (Study Leave) Rules, 1972.
