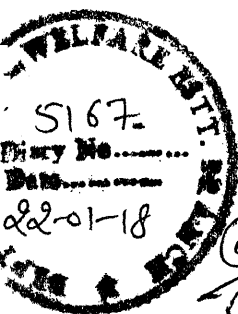

In order to make departments website GIGW compliant, Department of Information Technology is initiating re-development of contents of websites of all the departments hosted under CMS.

The major work under the re-development of websites is translation of existing contents from English to Hindi and it requires close coordination with the concerned departments. Accordingly, All HODs are requested to:
