

ORDER

Registration of GPRS SIM service providers for tracking of Paratransit and Public Service Vehicles in Delhi.

A meeting was held in the Conference Room of Hon'ble Minister Transport to discuss the issue of non-activation of GPS devices in Paratransit & Public service vehicles (PSV) on 17.11.2017. The DIMTS was directed to initiate the registration process of GPRS SIM providers to ensure that only genuine SIM Cards are installed in Public Service Vehicles.

A public notice dated 30/11/2017 was published in leading newspapers by Transport Dept. inviting proposals for provisioning of SIM cards and associated services in paratransit and public service vehicles.

On the basis of the list of GPRS service providers available on the website of Telecom Regulatory Authority of India (TRAI), DIMTS contacted various companies which are having their operations in Delhi.

An industry interaction meeting with GPRS SIM service providers was also held by DIMTS on 06/12/2017

In response to the public notices mentioned above, following GPRS SIM service providers submitted their proposals:

- i. M/s Mahanagar Telephone Nigam Limited (MTNL).
- ii. M/s IDEA Cellular Limited.
- iii. M/s Bharti Airtel Limited.
- iv. M/s Aircel Limited.
- v. M/s VODAFONE Mobile services Limited.

The above submitted proposals were evaluated by DIMTS from the perspective of the compliance with the public notice, specifications and associated corrigendum.

The consultant i.e DIMTS has informed that following two services providers have furnished their confirmation with respect to compliance on all points along with their financial quotes:

1. M/s Mahanagar Telephone Nigam Limited (MTNL)
2. M/s IDEA Cellular Limited.

As per recommendation of DIMTS, M/s Mahanagar Telephone Nigam Limited (MTNL) and M/s IDEA Cellular Limited are allowed to commence their operations with quoted rates of INR 495 + tax for a




