ORDER

Sub: Decisions of STA board dated 28/08/2018 regarding request for change/ modification/ alteration of routes of Maxi Cab vehicles.

A meeting of STA Board was held on 28/08/2018 at 11.00 AM wherein Agenda No. 10/2018 was placed before the STA Board regarding request for change/ modification/ alteration of routes of Maxi Cab vehicles for appropriate decision. The Board resolved that in respect of the routes where there is no objection from the individual route operators such routes may be modified/changed as an interim measure, as sought by the operators, subject to the outcome of DIMTS's route rationalization and last mile connectivity update study report.


There may be any possibility that the objection received against any route have not been placed before the STA board due to non-availability or displacement of the objection filed by any operator/public, these types of cases for change/ modification/ alteration of routes of Maxi Cab vehicles may be rejected immediately at any stage without providing any opportunity to the permit holder.

In view of above, I am directed to allow the change/ modification/ alteration of routes of following Maxi Cab vehicles, subject to the outcome of DIMTS's route rationalization and last mile connectivity update study report.


