IMPORTANT PROGRAMMES / SCHEMES OF THE DEPARTMENT OF
WOMEN & CHILD DEVELOPMENT FOR WOMEN & CHILD WELFARE

1. INTEGRATED CHILD DEVELOPMENT SERVICES : -

Integrated Child Development Services Scheme is a centrally sponsored scheme implemented through State Govt. since Oct 1975, aims at holistic development of children (0-6 Years) and pregnant and lactating mothers. It provides integrated services comprising of supplementary nutrition, immunization, health check-ups, referral services, pre-school non-formal education and health & nutrition Education.

Six Services of I.C.D.S.

- 1) Health Check-ups
- 2) Immunization
- 3) Supplementary Nutritional Support
- 4) Referral Services
- 5) Pre- School Education
- 6) Nutrition & Health Education

Target group under ICDS Scheme

- Children below 6 years of age.
- Adolescent Girls aged 11 -18 years (SABLA).
- Pregnant & Lactating mothers.

2. CHILD WELFARE

The Department of Women and Child Development, Govt. of NCT of Delhi in its endeavor to take up the responsibility for care & protection of children in difficult circumstances has adopted multifold approach towards providing services and infrastructure for different categories of children.

The State Govt. is implementing the Juvenile Justice (Care & Protection of Children) Act, 2000/2015 in letter and spirit and also implementing a Centrally Sponsored Scheme by the name Integrated Child Protection Scheme.

- The State Govt. has set up 3 Juvenile Justice Boards & 8 Child Welfare Committees till date for taking decisions for the juveniles in conflict with law and children in need of care and protection respectively.
- In addition to this the deptt. is in the process of setting up of CWC-IX & JJB-IV.
- State Govt. is maintaining 14 Children Homes for children in need of care and protection & 7 Institutions for Juvenile in conflict with law with facilities of education, health care, recreation, mental health, counseling etc.
- In addition to this, NGOs working in this sector are invited to get their Child Care Institutions registered and recognized under the provisions of the Act.
- At present there are 64 NGOs run CCIs shouldering the responsibility of the Govt. It also includes 09 Shelter Homes, 13 Open Shelters & 12 Adoption Agencies.
- The State Govt. under MOU with the GOI is implementing the Integrated Child Protection Scheme in Delhi w.e.f. the year 2009-10.
- The Department has set up a State Child Protection Unit and 4 District Child Protection Units to implement the objectives of the Scheme.
- At present 9 Shelter Homes, 13 Open Shelters & 3 State Adoption Agencies are being given Grant-in-Aid through Integrated Child Protection Scheme, besides conducting regular trainings of the stakeholders.

A. INTEGRATED CHILD PROTECTION SCHEME (ICPS)

The Integrated Child Protection Scheme (ICPS) is a centrally sponsored scheme of the Ministry of Women & Child Development, GOI that was launched in the year 2009. The scheme aims to provide a protective environment for all the children enabling them to lead a safe, secure and well protected life.

On an average about **8500** children are taken care of annually through institutional and non- institutional care under ICPS scheme at the State / District level.

Financial support is provided under ICPS to NGO run open shelters, shelter homes (Child Care Institutions) and specialized adoption agencies for up gradation and maintenance.

B. State Adoption Resource Agency (SARA):

State Adoption Resource Agency (SARA) under Integrated Child Protection Scheme (ICPS) has been set up for monitoring the Specialized Adoption Agencies (SAA's) and to support Central Adoption Resource Authority (CARA) in promoting in-country adoption and regulate Inter-country adoption in the State of Delhi. At present, 11 Specialized Adoption Agencies (SAA's) are recognized under relevant sections of Juvenile Justice Act 2015.

3. WOMEN EMPOWERMENT

The Women Empowerment Cell coordinates and supervises various schemes and programmes addressing welfare and empowerment of women of Delhi. These schemes and programmes can be broadly classified as:

- Preventive
- Protective and
- Empowerment

1. PREVENTIVE

I. Working Women Hostels

Two Working Women Hostels have been set up in the NCT of Delhi by the Department of Women and Child Development, Delhi govt. at Vishwas Nagar and Rohini. These Hostels provide safe accommodation to working/unmarried/widow/divorced/separated women. These WWHs have the capacity to accommodate 100 and 110 women respectively

II. PROTECTIVE

II. Institutions for Women

The Department is running one Statutory and two Non-Statutory Residential Institutions for the rehabilitation and empowerment of women.

Statutory Institutions

1. Nirmal Chhaya (Nari Niketan)

- Nirmal Chhaya is a statutory institution Under Section 21 of the Immoral Traffic (Prevention) Act, 1956. The Department declared Nirmal Chhaya as a Protective and Corrective Institution in 1988. Sanctioned capacity of the institution is 100 residents.
- Women and girls are admitted and discharged from the Institution as per the Court orders.
- The Institution provides free boarding, lodging, medical care, mental health care, protection, counseling, psychiatric treatment, vocational training, guidance, basic education and recreation activities for the residents.

Non-Statutory Institutions

1. Short Stay Home:-

- Short Stay Home provides short or temporary shelter to the needy women/girls who are in distress in the age group of 18-45 years, whose restoration/re-adjustment in their families or admission in suitable institutions is still pending. Sanctioned capacity of the institution is 50.
- Women are encouraged to take up basic education courses and vocational training in order to rehabilitate them back into their families. A cutting & tailoring instructor is available in the Short Stay Home for skill development training of the residents.

- **Eligibility Criteria:**

The Short Stay Home is open 24 hours for women/girls who are:

- Victims of family discord, mal-adjustment and victims of ill-treatment; victims of domestic violence; destitute, deserted women/girls who are in need of immediate protection.
- Women/ girls who are suffering from incurable, infectious or communicable diseases or physical disability or mentally retarded or leprosy affected are not eligible for admission.
- If a woman is having dependent children, then only such children, who are below six years of age will be permitted to stay with her, provided they are not suffering from any infectious or incurable disease.
- Children above six years of age of women residing in short stay institution are kept in the Children Institution run by the Department as per provisions of Juvenile Justice Act

2. Widow Home:-

Widow Home was established in the year 1970. It provides shelter, free boarding, lodging, education and vocational training facilities to the widows.

Eligibility Criteria:

- Widows who are homeless or not having any means of subsistence, in moral danger and are bonafide residents of Delhi.
- Women suffering from incurable infection /communicable disease/ physical disability/ mental retardation are not eligible for admission.

3. After Care Home for Women, Nirmal Chhaya Complex, Jail Road, New Delhi:-

Key Features

- After Care Home has a sanctioned capacity of 100 women in the age group of 18-35 years. This Home follows the provisions of the Juvenile Justice Act.
- It provides non-formal education, school education and after care services like training in nursing and mid wifery, nursery teacher training, training in cutting and Tailoring, Beauty Culture and Hair dressing through Industrial Training Institute (ITI), a Government of Delhi institution in order to re-habilitate the residents.
- Efforts are made to secure their placements in private sector or Govt. sector.
- Efforts are also made to arrange their marriage as another mode of rehabilitation in the society. Free boarding, clothing, bedding, medical facilities and counselling are provided to such women.

Eligibility Criteria

- Discharged residents of custodial and non-custodial institutions are admitted in this Institution who are in the age group of 18-35 Years and whose conduct/behaviour was found to be satisfactory.

4. Shelter Home for Pregnant & Lactating (Destitute) Women

Key Features

- Two shelter homes were set up on 08.02.2011 for (destitute) Pregnant and Lactating women in Sarai Rohilla and Jahangirpuri.
- These shelter homes are providing comprehensive services of care, protection and nurture the women & children.

Eligibility Criteria

- Pregnant / Lactating women who are destitute

III. EMPOWERMENT

WORK CENTRES FOR WOMEN:-

Work Centres for Women impart training in cutting and tailoring in resettlement colonies under the 20 point programme of the Prime Minister. Sanctioned capacity of each Work Centre is approximately 50.

Other functions:

- Implementation of Immoral Traffic (Prevention) Act, 1956
- Protection of Women from Domestic Violence (PWDV) Act, 2005
- The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013
