**Sub.:- Furnishing of information with reference to Rule 17 of Transaction of Business of Govt. of NCT of Delhi Rules, 1993, on every Monday.**


As per order dated 29.12.2016, of the Deputy Chief Minister/Minister (SW/WCD), a statement indicating the current status of important proposals/matters related to the Department, the progress made during every week, the expected timeline by which the same is to be achieved and also the constraints and coordination which may be required, is required to be submitted to the Hon'ble Lt. Thereafter, the same reporting mechanism described above is to be followed in respect of each sub-project/milestone.
