**ORDER**

**Sub: Requirement of ACRs/APARs folder for the purpose of grant of MACP benefits.**

This is with reference to letter No. F.3(79)/DSW/Vig./2012/Misc./49 dated 02.02.2018 received from Supdt. (Vig.), Deptt. of Social Welfare (DSW), GNCTD, vide which the status in respect of ACRs/APARs of the following Ex-Cadre officers have been received, as per details below :-

Since, as per the above mentioned letter dated 17.05.2016 of DSW, the ACRs/APARs in respect of above mentioned officers **were forwarded to the Supdt. (Vig.), WCD**, as such, the Supdt. (Vig.), WCD is hereby directed to forward the said ACRs/APARs, to this office **within 07 days of receipt of this letter**, for further processing their MACP cases.

Earlier, many communications had been made to both Vigilance Branch (WCD) & Vigilance Branch (DSW) in these past 02 years, but till date no ACRs/APARs have been received from either of the branches, causing delay in grant of MACP benefits to these retired employees.

In case, the ACRs/APARs are not received within stipulated time of 07 days, it will be presumed that being the retired employees, these officers satisfy the benchmark of "Good" on an average in respect of ACRs/APARs gradings and their cases for grant of MACP benefits will be processed further, taking on an average "Good" as their ACRs/APARs gradings.

This may be treated as "**MOST URGENT/TIME BOUND**".
