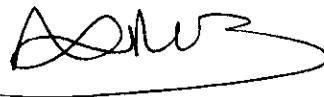
Subject: Allocation of Revised Estimates for the FY 2017-18.

Sir/ Madam,

In pursuance of letter No. **F.2(1)/2017-18/Fin.(B)/233-242 Dated 01/03/2018 issued by Finance Department** regarding allocation of revised estimates in respect of this department under Demand No. 8 - Major Head-'2225', '2235', '2236' & '4235', I am directed to reallocate the Budget Revised Estimates for the Financial Year 2017-18 based on the requirement furnished by respective HOOs/DDOs as per Annexure attached. Further, all the PIO/DD/HOO/DDOs shall ensure that:

1. At the outset, no expenditure is incurred in excess of allocated revised estimates.
2. Expenditure must be incurred for the purpose for which funds have been provided.
3. Adequate mechanism shall be effectively applied for prevention, detection of errors & irregularities in financial proceedings so as to safeguard of public money:
4. All the rules/instructions for principles of expenditure and payment of state exchequer/ money shall be strictly adhered to including economy instructions issued by GOI and GNCTD from time to time.
5. HOOs/DDOs shall be in a position to estimate the anticipated of saving or excess of every month.
6. In case there is any extreme urgency/demand or excess expenditure has been incurred over the RE 2017-18 the same may be intimated to HQ immediately.
7. Rush of expenditure, particularly in the closing months of the financial year, shall be regarded as breach of financial propriety and shall be avoided.
8. **Expenditure up to the month of February 2018 with PAO reconciled statement must be submitted to S.O. (Planning), WCD by 15.03.2018.**
9. Non-utilization of the available provisions/funds by any office will be viewed seriously, as this would have deprived of some other needy unit from utilizing the same.
10. Submit detailed monthly expenditure statement to the S.O. (Planning), Planning Branch, DWCD by 3rd of the following month positively and PAO reconciled statement of the same by 10th of following months.

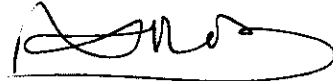

13. All proposals which require the approval of higher authorities as well as Finance Department must reach at HQ latest by 15.03.2018.

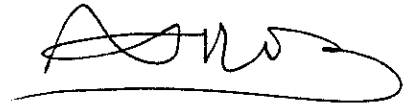

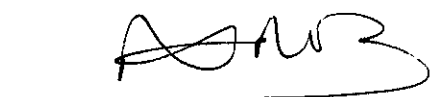
