**OFFICE ORDER**

ICDS with its multi sectoral approach provides its services under three broad headings which are Nutrition, Health and Pre school education. Integrated Child Development Services Scheme aims at providing services to Pre School children in an integrated manner so as to ensure optimum growth and development. Non-formal Pre school Education is a very crucial component as it lays the foundation for adequate physical, psychological, cognitive and social development of the child.

In order to move a step towards this direction, I am directed to convey the permission of the competent authority to **Angelique foundation** as a part of its Corporate Social Responsibility (CSR) to collaborate with Department of Women and Child Development for providing continuous support in delivering quality pre school education for the Welfare of the children of Anganwadi Hubs under WCD by way of supporting in installing happy and functional Activity centres in the Anganwadi Hubs within the approved norms.

**ROLE OF ANGELIQUE FOUNDATION:**

- The Angelique Foundation will provide intellectual input, support in installation and training of teachers in the happy and functional Activity Centre. It will also provide technical inputs for design and type of material to be used to make the environment attractive and will also fill the gaps in terms of books, toys and fund as and when required.
- The Foundation will provide a platform for government to work in a synergistic manner to achieve the objectives as per ICDS. The Foundation will place additional human resources over and above the norms of the ICDS during the period of collaboration.
- The Foundation will implement and monitor activities to improve the condition of existing Anganwadi centres. It will also explore possibilities for more space to run Anganwadi centres while implementing community based initiatives as a part of the overall project.


**ROLE OF WCD :**

- Department of WCD would ensure that :
  - The Anganwadi centres are available for implementing activities in line with the ICDS functions as per decided timings with requisite staff in place as per ICDS norms (one Anganwadi worker and one helper in each centre).
  - Smooth and timely provision of supplies and materials at the Anganwadi Centres as per ICDS norms.
  - Joint responsibility of maintaining records related to materials provided at the Anganwadi centre under the project by the Department and Foundation .
  
- Department of WCD would be providing the vacant room/spaces and moveable materials for the new functional Activity centre within approved norms in order to provide various facilities for benefitting the target children in the Anganwadi Hubs such as :
  - Furniture (Carpets, Floor covering, tables, chairs, racks, bean bags etc.), Electricals, CCTV, Motivational posters, Cognitive activities and books.

The goal of the aforesaid project is to improve the quality of life of children in poor and marginalized communities by way of installing Activity Centres. The Department will support the initiative by providing human and material provisions within its approved norms and **without** any additional financial cost to DWCD.

**The abovementioned permission is subject to the following conditions:**

- Angelique Foundation will ensure that the locations identified for the opening of Activity Centres should be prioritized in such a manner that an untapped/ uncovered area is brought under this initiative for the benefits of the uncovered beneficiaries also.
- Photographs if taken during the implementation of aforesaid project should not be released in media without prior permission of the Department.
- No Financial implications shall be borne by the Department in this reference.
