ORDER

WHEREAS, Shri Bir Singh Kanwar Singh, Craft Instructor, was charge-sheeted under Rule 14 of the CCS (CCA) Rules, 1965, vide Memorandum dated 11.08.2015 on the following Articles of Charges, purported to show lack of devotion to duty and act of unbecoming of a government servant in contravention to Rule 3 of the CCS (CCA) Rules:-

Article No. 1 Shri Bir Singh, Grade — IV (DASS)/LDC while posted at SDM Office, Seelampur during the period from 07.07.2010 to 26.02.2014 and entrusted the job of verification of Caste Certificates was handed over the applications for issuance of SC Certificates in respect S/Sh.Shubham, Tushar and Suraj All Sons of Shri Birju, Shri Sunil S/o Shri Banarsi and for issuance of OBC Certificate in respect of S/Sh. Udai Kumar Mishra S/o Shri Jai Kishan Mishra, Kanhaiya Mishra S/o Fuddan Mishra, S N Mishra S/o B. Mishra, Rajpal Mishra S/o Shri S R Mishra and Syed Dilshad Ahmed S/o Syed Irshad Ahmed. However, Shri Bir Singh failed to conduct any field verification and submitted false verification report leading to the issuance of Caste Certificates to the applicants.

Article No.2 That Shri Bir Singh, Grade – IV (DASS)/LDC while posted at SDM Office, Seelampur during the period from 07.07.2010 to 26.02.2014 failed to verify the genunineness of the documents submitted by the applicants such as electricity bills, recognition certificate issued by the Gazetted Officers, as

proof, which are found to be forged and thus acted in connivance with some touts in creating forged documents, obviously, for a price which are then being used for issuance of caste certificates.

Article No.3 That Shri Bir Singh, Grade – IV (DASS)/LDC while posted at SDM Office, Seelampur during the period from 07.07.2010 to 26.02.2014 has verified the application of Shri Sunil S/o Shri Banarasi R/o House No. 166, Jhuggi T. Huts, Old Seelampur, Delhi bearing application ID 90519429455916 for issuance of SC certificate, who ghas not been residing under the territorial and legitimate jurisdiction of Sub Division, Seelampur.

The above acts on the part of Shri Bir Singh, Grade – IV (DASS)/LDC shows malafide intention, lack of integrity and devotion to duty which is unbecoming of a Govt. Servant thereby violating the provisions of Rule 3 of CCS (Conduct) Rules, 1964.

- 2. AND WHEREAS, the <u>Statement of Imputations</u> in support of the articles framed against Shri Bir Singh, Grade IV (DASS)/LDC, purporting lack of integrity and devotion of duty and an act of unbecoming of a government servant in contravention to the provisions of Rule 3 of CCS (CCA) Rules, 1965 was also served upon the official.
- 3. AND WHEREAS, the present disciplinary proceedings were initiated on the specific recommendation of the O/o District Magistrate (North East), Revenue Department, GNCTD.
- 4. AND WHEREAS, on nomination by the O/o District Magistrate (North East), Revenue Department, GNCTD vide Order dated 23.01.2017, Shri Pawan Kumar, Adhoc DANICS/SDM (HQ.), District North East, Revenue Department, GNCTD, was appointed as the Inquiry Officer and vide Order dated 25.01.2017, Shri N K Meena, Grade I (DASS)/Tehsildar (Seelampur), District North East, Revenue Department, GNCTD was

appointed as the Presenting Officer, to inquire into the charges framed against Shri Bir Singh, Grade – IV (DASS)/LDC.

- 5. AND WHEREAS, Shri Pawan Kumar, Inquiry Officer, submitted his final report in the Inquiry proceedings vide letter dated 06.03.2018 in respect of Shri Bir Singh, Grade IV (DASS)/LDC (Charged Official).
- 6. AND WHEREAS, an intimation has been filed with the Department of Women & Child Development, GNCTD that during the intervening period Shri Bir Singh, Charged Officer, expired on Bir Singh, LDC has expired on 21.02.2018.
- 7. AND WHEREAS, the Department of Personnel & Training OM No. 11012/7/99-Esstt. (A) dated 20th October, 1999, mandates that in the event of death of the charged officer/official during the pendency of the disciplinary proceedings, the disciplinary cases initiated against should be closed immediately.
- 8. AND WHEREAS, I, SHILPA SHINDE, DIRECTOR (DWCD), GNCTD, being the Disciplinary Authority in the present case, in exercise of the powers conferred under the provisions of the CCS (CCA) Rules, 1965, without going into the merits of the case and final inquiry report submitted by the Inquiry Officer, hereby direct closure of the disciplinary proceedings in respect of Shri Bir Singh, Grade IV (DASS)/LDC, owning to his death on 21.02.2018. Further, it is ordered that Late Shri Bir Singh, Grade IV (DASS)/LDC, shall be eligible for full pay and allowances for his period of suspension and the period of suspension shall be treated as period spent on duty for all purposes. Besides, it must be endured that Legal Heirs of the deceased employee should not be put to any hardship in getting their dues from the government.
