At present there are six Juvenile Justice Boards operational in GNCT of Delhi to deal with Child in conflict with Law from various districts. The Department has appointed probation Officers/ Welfare officers in the said Juvenile Justice Boards for preparation of the Social Investigation Reports of the CCL.

In this regard, the Department hereby declares the Superintendents posted at various Juvenile Justice Boards as "District Probation Officers", to perform the following duties assigned to them:

- I. The Superintendents posted at JJB-I, II, III, IV, V and VI would function as Nodal Officers for undertaking various assignments between the JJBs and the Department of WCD.
- II. The Superintendents posted at JJB-I, II, III, IV, V and VI are hereby declared as DDO/HOO of the respective JJB under the Rule-14 of Delegation of Financial Power Rules, 1978.
- III. The Superintendents being declared DPOs would be responsible to monitor and supervise the work of the Probation Officers posted at respective JJBs keeping in view the best interest of the Children as per Juvenile Justice (Care & Protection) Act, 2015 and Model Rules, 2016.
