With this arrangement the above CDPO's (CDC) will carry out inspections of the Projects, Anganwadi Centers and SHG Kitchens under the supervision of the District Women & Child Development Officers of respective Districts to ensure quality delivery of services through the Aganwadi Centers.

No additional pay and allowances shall be admissible to above officers, who are being assigned to hold current charge of the routine duties of the posts of Child Development Project Officers as a

home

temporary measure. The officers will be performing only the routine day-to-day duties of non-statutory nature of the post of CDPO's.

District Women & Child Development Offices shall provide all support to above CDPO's in carrying out regular inspection of the field units of ICDS within their jurisdictions, focusing exclusively on improvement of services delivery for the poor section of the society.

These officers shall draw their pay and allowances from the posts of Supervisor Gr.II, held by them substantively while discharging current duty charge of the post of CDPO. Assignment of current duty charge shall not make them entitled for benefits as admissible to regularly promoted officers and this assignment shall automatically come to an end on their regular promotion to the posts. The Department reserve the right to withdraw the CDC at any time, without assigning any reasons.
