**ORDER**

For implementation of provisions of Protection of Women from Domestic Violence Act and Rules, the Department of Women & Child Development, GNCTD has created 23 posts of Protection Officers as per Order No. F.60(73)/(3)/DSW/Admn./PWDVAct/2006-07/Pt./29479-90 dated 16.10.2015.

Recruitment Rules for the post, as per mandatory advice of Union Public Service Commission were notified on 30.03.2016 prescribing maximum age limit of 30 years. For filling up the posts on regular basis, the Department has submitted the requisition for the 23 posts to Delhi Subordinate Services Selection Board and the recruitment process is about to start.

In the absence of post creation orders and RR, the Department has engaged few applicants as Protection Officers on contractual basis, out of which 17 are presently working. Now, for the participation of the existing working contractual Protection Officers in the regular recruitment process to be initiated by DSSSB as per requisitions dated 28.09.2016 and 12.01.2018. The competent authority has granted age relaxation for the years of service completed on contract basis as Protection Officer as a one time measure, if otherwise found eligible for the post as advertised by DSSSB.

This issues with the prior approval of the Hon'ble Lt. Governor, Delhi.
