Further, the Voluntary Consumer Organisations/ NGOs willing to apply for funding should first have a valid registration with the NGO-Darpan portal (on the website: <http://ngodarpan.gov.in>). It is mandatory to submit project proposals online. Time-barrred or incomplete proposals will be deemed to have been rejected summarily. No proposal sent physically in the Department will be considered.
