During the operation of Model Code of Conduct, no advertisement can be displayed in any News Paper/ Magazines/ Outdoor Media and aired/broadcast in radio/TV channel at government expenses. Besides this, no Government premises can be allowed to be used for advertisement.

You are requested to ensure that if any such advertisement is displayed/aired/broadcast, the same shall be removed/discontinued immediately. Similarly all advertisements on Government premises shall be removed. Strict vigil is to be maintained to ensure that no such advertisement comes up during the operation of model code of conduct. The Department must constitute a team to regularly inspect the premises of the department and remove any such advertisement.
