

On the basis of the particulars/documents in respect of Group-D employees received in this Directorate from the various department of GNCT of Delhi a Tentative Eligibility list has been prepared for promotion to the post of Laboratory Assistant in Directorate of Education, GNCTD. In this regard I am directed to forward herewith a copy of the same and request you to kindly circulate it amongst all concerned officials working in your Department/Offices at the earliest and objection(s), if any, raised by them may be sent to this office by 22.12.2019 along with the concerned page of the Tentative list in which their names appear. If no objection/request for removing the discrepancies/shortcomings is received within stipulated period, it will be assumed that they have nothing to say in this regard and the tentative list will be treated as final after removing the objection, so received.

Tentative list has been prepared on the basis of 'Date of appointment (DOA) and where 'DOA' is same between two officials then Year of 'acquiring the required qualification' and if that too is also same then 'Date of Birth' has been considered for preparing seniority.

All concerned Group-D employee may be also advised to check their particulars and submit the objection(s), if any, to remove the discrepancies/shortcomings, if any, as mentioned against their names in the list through their concerned Competent Authority along with attested copy of supporting documents by 22.12.2019 positively.

It is further reiterated that the parent department will be held responsible if eligibility of any official is rejected at any stage due to furnishing/forwarding of incorrect information/services particulars. It is further requested to ensure that all particulars shown in the tentative list of respective employee is correct as per your office records/service book etc specially date of appointment, date of birth, category and date of acquiring essential qualification. If any discrepancies are found in particulars, it may invariably be intimated within the stipulate period for taking further necessary action in the matter. Any objections received after the cutoff date will not be entertained by this Directorate and no further extension for raising objections will be granted.
