FIRE SAFETY CERTIFICATE

Certified that **The Gold Inn Guest House located at 12/24, WEA, Karol Bagh, New Delhi- 110005**, comprised of basement, Stilt, ground plus three upper floors, using basement as storage, Stilt for parking ground floor as reception & 05 guest rooms, first, second & third floor each having 06 guest rooms respectively (total 23 guest rooms), pantry for staff in temporary shed on terrace was granted FSC by this department vide letter No. F.6/DFS/MS/GH/2016/NDZ/381 dated 10.03.2016. The guest house was re-inspected by the officer concerned of this department on 15.03.2019 in the presence of Sh. Satyam Dass (manager) and found that the owner/occupier have removed the pantry for staff in temporary shed on terrace and deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class residential (guest house only) with effect from 25/03/19 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010, printed below.

4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form "J" [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry. The form is available on www.dfs.delhigovt.nic.in.
8. All the means of escapes /exits shall not be locked/bolted/blocked at any time for safe evacuation of the occupants in case of emergency.
