
**FIRE SAFETY CERTIFICATE**

Certified that the M/s World Food Art Eating House ( Moh Maya Café & Bar), located at premises No. 2527 at GF & FF, Hudson Lane, Delhi-110009 in the building comprised of basement, ground and 03 upper floors owned/ occupied by M/s World Food Art Eating House have complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and verified by the officer concerned of Fire Service on 04.05.2019 in the presence of Sh Gagan and that the building/ premise is fit for occupancy Class Assembly for ground & first floor only with effect from 22/5/19 for a period of 03 (Three) years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

**Conditions for the validity of Fire Safety Certificate:**

1. All the fire safety arrangement provided there-in shall be maintained in good working conditions at all times.
2. Loss of life or property due to non functional fire safety measure shall be at the responsibility of the management.
3. The trained fire fighting staff should be available round the clock.
4. The use of basement shall be in accordance with the provision contained in UBBL 2016/ NBC Part 4, 2016.
5. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
6. This certificate cannot be treated in any case for regularizations of unauthorized construction.
7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
8. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [WWW.dfs.Delhigovt.nic.in](http://WWW.dfs.Delhigovt.nic.in)
9. All the means of escape shall be kept free of any obstruction all the time to evacuate the occupant, in a safe manner, in the event of emergency.
10. This FSC is valid for ground and first floor only.
