6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form "J" [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry. The form is available on www.dfs.delhigovt.nic.in.
8. All the means of escapes /exits shall not be locked/bolted/blocked at any time for safe evacuation of the occupants in case of emergency.
9. This Fire Safety Certificate is only for guest rooms.
