FIRE SAFETY CERTIFICATE

Certified that **Invitation Ceremonial** located at **B-12, G.T.K Road Indl. Area, Delhi-110033** comprised of **Basement + Ground + Two upper floors with Basement for service, Ground and first floor for Banquet Hall, Second floor for office & Kitchen** owned/ occupied by **Invitation Ceremonial** was granted fire safety certificate vide letter no. **F6/DFS/MS/2016/WZ/979 dated 09.07.2016**. The premises was re-inspected by the officer concerned of Fire Service on **19.06.2019** in the presence of **Sh. Subhash Kakkar** and observed that all the fire prevention and fire safety arrangements as provided in the premise found good working condition. The premise have therefore deemed complied with the fire prevention and fire safety measures in accordance with the rule 33 of Delhi Fire Service Rules, 2010 and that the building / premise is fit for occupancy class **Assembly Buildings (Banquet)** with effect from ~~3-7-19~~ for a period of **three years** in accordance with rules 36 unless renewed under rule. 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

Conditions for the validity of Fire Safety Certificate:

1. All the fire safety arrangement provided there-in shall be maintained in good working conditions at all times.
2. Loss of life or property due to non functional fire safety measure shall be at the responsibility of the management.
3. The trained fire fighting staff should be available round the clock.
4. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
5. This certificate cannot be treated in any case for regularizations of unauthorized construction.
6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
7. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on WWW.dfs.Delhigovt.nic.in
8. All the means of escape shall be kept free of any obstruction all the time to evacuate the occupant, in a safe manner, in the event of emergency.
