- 8. All the means of escape shall be kept free of any obstruction all the time to evacuate the occupant, in a safe manner, in the event of emergency.
- 9. This FSC is valid for existing pucca structure /building only as earlier approved by this department no Tentage /temporary structure other than pucca structure in the premise, can only be verified after getting reference from concerned building Authority/ local authority
