AND WHEREAS ZRO (NE)-II has reported that Sh. Rahul is habitual absentee since his joining. He remained absent w.e.f. 01.09.2014 to 15.10.2015 and w.e.f. 01.12.2018 to till date in unauthorised manner without prior approval/intimation.

AND WHEREAS several letters/reminders were issued to the individual by the ZRO(NE)-II on 23.07.2018, 08.08.2018 & 22.10.2018 but he was not joined till date.

AND WHEREAS final reminder for directing him to join his duty was issued by the ZRO(NE)-II on 19.11.2018 but inspite of that he was not joined the duty.

AND WHEREAS In-house inquiry proceeding initiated against Sh. Rahul S/o Lt. Sh. Man Pal, PCAMR on M/Roll. Notices for hearing was sent to his available official address on dated 20.05.2019, 03.06.2019, 26.06.2019, 03.07.2019 and final opportunity has given to him on dated 11.07.2019, but he did not appear before the Inquiry Officer.

NOW THEREFORE, Member (Admin.) being Disciplinary Authority vide his orders dated 05.12.2019 has ordered to disengage the services of Sh. Rahul S/o Lt. Sh. Man Pal, PCAMR on Muster Roll C/o ZRO (NE)-II from Delhi Jal Board with immediate effect.
