Sub:- Publication Final List of Identified Manual Scavengers in District Shahdara as per prohibition of Employment as Manual Scavengers and Rehabilitation Act. and Rules 2013.

Sir,

With reference to the above cited subject, it is stated that as per the provisions of Prohibition of Employment as Manual Scavengers and Their Rehabilitation Act/Rules, 2013, and in accordance with the notification issued by order and in the name of the Lt. Governor of NCT of Delhi no. 28(15)/2017-18/DSCST/SCP/11810-841 dated 22.11.2017, a District Level Survey Committee for survey of manual scavengers in District Shahdara was notified.

01. The District Survey Committee, so notified, conducted field survey and prepared a "Provisional List" of 28 manual scavengers.
02. As per Rule 11(9) of PEMRS, 2013 the Committee through notice dated 05.10.2018 in the "Times of India" invited claims and objections for inclusion or exclusion of names in the above mentioned "Provisional List" a direction of 15 days from the date of publication of the said notice i.e. 20.10.2018 were given to file such claims and objections in the prescribed format before the "Designated Officer" Shri Rajesh Choudhary, SDM (Vivek Vihar), G-Block, 1st Floor, DC Office Complex, Nand Nagri, Delhi - 110093.
03. However, No Claims and Objections were received during the stipulated time period of 15 days. Therefore the list was presented before the District Level Survey Committee, District Shahdara and the Committee, vide its meeting dated 01.11.2018 unanimously decided to accept and finalize the "Provisional List". The list was presented before the District Level Survey Committee, District Shahdara and Committee *and accepted*.
04. Accordingly, in pursuance of Rule 13(27) of PEMSR, 2013, the "Final List" is forwarded for further necessary action at the end of "State Monitoring Committee".
