

**NOTIFICATION**

In exercise of the powers conferred by (xxiia) of Section 109 and (4)(a) of Section 83 of the Waqf Act, 1995, read with Government of India, Ministry of Home Affairs, Notification No. 572(E) dated 9<sup>th</sup> August, 1996, the following amendments to the Delhi Waqf Rules, 1997 are hereby notified :-

**RULES**

1. **Short title and commencement:-** (i) These rules may be called the Delhi Waqf Tribunal Rules, 2019.  
(ii) They shall come into force on the date of their publication in the Delhi Gazette.

2. In the Principal Rules, for Rule 81, the following rule shall be substituted, namely:-

(i) **Constitution of Tribunal:-** There shall be one Chairman and not more than two other members in the Delhi Waqf Tribunal. The Tribunal shall consist of Chairman and members as prescribed in the section 83(4) of the Waqf Act as amended by the Waqf (Amendment) Act, 2013. The appointment of Chairman and member u/s 83(4)(b) shall be made in consultation with Registrar, Delhi High Court and Services Department of Government of National Capital Territory of Delhi respectively.

(ii) A member u/s 83(4)(c) of the Waqf Act, 1995 Shall not be eligible for appointment unless he/she has attained the age of Thirty Five years and having knowledge of Muslim Law and Jurisprudence. Preference may be given to the person having Masters Degree in Islamic Studies/Urdu/Persian/Arabic or a Bachelor of Law and work experience in the relevant field/Government Service.

3. In the Principal Rules, for Rule 82, the following Rule shall be substituted, namely:-

**Term of Office:-** Every person appointed as member under Section 83 (4) (c) shall hold office for a term of three years from the date on which any one of them enters upon his office, but shall be

eligible for reappointment for another term of three years, provided that no such person shall hold office as member of the Tribunal after he has attained the age of sixty five years.

In the Principal Rules, for Rule 83, the following shall be substituted, namely:-

(i) **Age of Superannuation:-** The date of superannuation of the Member of the Tribunal appointed u/s 83(4)(c) shall be the last day of the month in which he attains the age of sixty five years. The Chairman appointed u/s 83(4)(a) and member appointed u/s 83(4)(b) of the Waqf Act shall be governed by their respective Services Rules.

(ii) **Pay and Increments:-** The Member appointed u/s 83(4)(c) of the Waqf Act shall receive pay in the pay equivalent to the member appointed u/s 83(4)(b) of the Waqf Act, earn annual increments in accordance with the rules applicable for grant of annual increments in the pay.  
**AND**

Where it relates to the appointment of a retired government officer as Member, he shall draw his initial pay in accordance with the principle of Last Pay Drawn minus Pension as per the OM No. F20/47205-AC/204-208 dated 04.12.2015 issued by the Finance Department of GNCT of Delhi.

(iii) **Dearness Allowance:-** The Members appointed u/s 83(4)(c) of the Waqf Act shall receive dearness allowance appropriate to their pay at the rates as admissible to Group A officers of the Government of India of appropriate level.

(iv) **Leave Sanctioning Authority:-** The Secretary (Revenue) of the Government of National Capital Territory of Delhi shall be the authority to sanction leave to the Member appointed u/s 83(4)(c) of the Waqf Act.

(v) **Travelling allowance:-** The Members of the Tribunal while on tour or on transfer (including the journey undertaken to join the Tribunal or on the expiry of the term with the Tribunal to proceed to his home town), shall be entitled to travelling allowance, daily allowance, transportation of personal effects and other similar allowances at the same scale at the same rate as are applicable to a Joint Secretary to the Government of India.

(vi) **Accommodation:-** The Chairman and Members of the Tribunal may be entitled to use of an official residence from the government of the type admissible as per their rank/level stationed at Delhi on the payment of license fee at the rates determined by the government from time to time. When the Chairman or member is provided with or does not avail himself of the accommodation, he may be paid every month an allowance at the rate approved by the Government from time to time.

(vii) **Facility of conveyance:-** The Chairman and members of the Tribunal may be entitled to facility of official vehicle for official purposes in accordance with the staff car rules and guidelines issued by the Government from time to time.

(viii) **Facility of Medical Treatment:-** The Member appointed u/s 83(4)(c) of the Waqf Act other than retired Government official/officer, a fixed medical allowance as per Government rules may be paid.
