**ORDER**

**Cancellation of Appointment/Posting order to the post of PGT (HINDI)(169/14)**

Whereas, SATYVIR SINGH (DOB-02/01/1986) (Roll No.22002773) had been nominated by DSSSB for post PGT (Hindi) against Post Code 169/14 vide letter No. F.1(158)/DSSSB/P&P/2012/776 dated 19/09/2018 for the post of PGT(Hindi) against Post code 169/14. The candidate called for documents verification as per memorandum of offer of appointments as per 08/10/2018 for appearing for documents verification on 22/10/2018.

2. Sh. SATYVIR SINGH NEELAM (DOB-02/01/1986) (Roll No.22002773) had been appointed/posting vide order of even No. dated 24/12/2018, having Emp. I.D. 20183062 and posted in Radhey Shayam Park SBV -1003152 with direction to join latest by 24/01/19. However, he has given in writing as per representation having Dy. No.1050/E-II dated 14/05/2019 is stated that "due to some unavoidable circumstances, I am unable to join this post." Hence, as the candidate is no more interested to join the said post and his candidature may be cancelled and dossier returned to DSSSB.

Further, as per DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period and **would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

4. Now, therefore, in view para.1-2 and OM referred to in para.3 above prior approval of the Director, DoE, the appointment/posting order dated 24/12/2018, interalia candidature in respect of Sh. SATYVIR SINGH (DOB02/01/1986) (Roll No.22002773) is hereby cancelled for the post code 169/14 and the dossier is returned to DSSSB.
