**ORDER**

**Cancellation of Appointment/Posting to the post of PGT (HINDI)(136/12)**

Whereas, of Pawan Kumar Pandey (DOB 01/07/1981) (Roll No.22007011) had been nominated by DSSSB for post PGT (Hindi) against Post Code 136/12 vide letter No.F.1(158)/DSSSB/P&P/2012/46-48 dated 23/01/2018 and result notice No.584. Accordingly an offer of appointment was issued to her vide this office memorandum dated 17/05/2018 for accepting the offer of appointment on the terms and conditions stipulated in the above said memorandum and advised to appear in person on 30/05/2018. The candidate present on 30/05/2018 for initial verification of documents.

2. Pawan Kumar Pandey (DOB 01/07/1981) (Roll No.22007011) had been appointed/posting vide order of even No. dated 17/10/2018, having Emp. I.D. 20182731 and posted in Gokhle Marg-SBV-1207014 with direction to join latest by 29/10/18 and the candidate sought extension vide letter having diary no.6519/E-II dated 30/10/2018 extended up to 14/11/18. The candidate sought once against extension vide letter having diary no. 6668/E-II dated 19/11/18 and same had been granted till 31/12/18. In view of above fact that the candidate given sufficient opportunity to join the post. Hence, it seems that the candidate is no more interested to join the said post and his candidature may be cancelled and dossier returned to DSSSB.

And Whereas, as per DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period and **would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

4. Now, therefore, in view para.1-2 and OM referred to in para.3 above prior approval of the Director, DoE, the appointment/posting order dated 17/10/2018, interalia candidature in respect of Sh.Pawan Kumar Pandey (DOB 01/07/1981) (Roll No.22007011) is hereby cancelled for the post code 132/12 and the dossier is returned to DSSSB.
