ORDER

WHEREAS on the basis of written examination conducted by Delhi Subordinate Services Selection Board, the following candidates were provisionally selected & nominated for appointment to the post of TGT(Computer Science) under Post Code 192/14 in Directorate of Education, Govt. of National Capital Territory of Delhi.


And WHEREAS, after completion of document verification, the candidates were directed to report to the Chairman Medical Board of the respective hospitals mentioned against their names in the table below vide dispatch numbers mentioned against their names in the same table.

And WHEREAS, the candidates failed to report to their respective hospitals and subsequently letter no DE.4(20)/1/E-IV/Appt.TGT(CS)/2018/6115 dated 09/05/19, letter no. DE.4(20)/1/E-IV/Appt. TGT (CS)/2018/6110 dated 09/05/19 and letter no.
