Accordingly, now the nomination is rectified as that of Roll No.111210500029. Remaining contents of the aforementioned Supplementary Result shall remain unchanged."

And whereas, DSSSB vide supplementary Result Notice No. 466 dated 21/06/2019 in r/o post code 105/17, PGT (Commerce)-Female the name of Ms. Nidhi having roll no. 121810500164 was nominated erroneously instead of Roll No. 111210500029 by DSSSB and in this regard DSSSB has already issued corrigendum dated 14/11/2019 to rectify this error.

Now therefore, the appointment in r/o Ms. Nidhi (Emp. ID 20191905) is hereby cancelled with immediate effect. The candidature of the Ms. Nidhi, Roll No.121810500164 is hereby rejected.
